The PTI's are Hermargs Institute - Morogoro, Karagwe Institute of Health Sciences - Kagera, Chato College of Health Sciences – Geita, City College of Health and Allied Sciences – Dodoma Campus and Marian University

College - Bagamoyo approved to offer Basic Technician Certificate in Pharmacy (NTA Level 4) up to Ordinary Diploma in Pharmaceutical Science (NTA Level 6).

Together with the above approved PTI's, the Council also granted

approval for six intern centres to offer internship training for intern pharmacists. Those centres are Benjamin Mkapa Hospital - Dodoma, Milembe National Mental Hospital - Dodoma, Kitete Regional Referral Hospital - Tabora, Maweni Regional Referral Hospital - Kigoma, St. Francis Referral Hospital - Ifakara

Morogoro and Singida Regional Referral Hospital - Singida.

The Registrar emphasized that, all approved institution to continue adhering to the standards and the conditions of permits given and make sure that they generate competent pharmaceutical personnel.

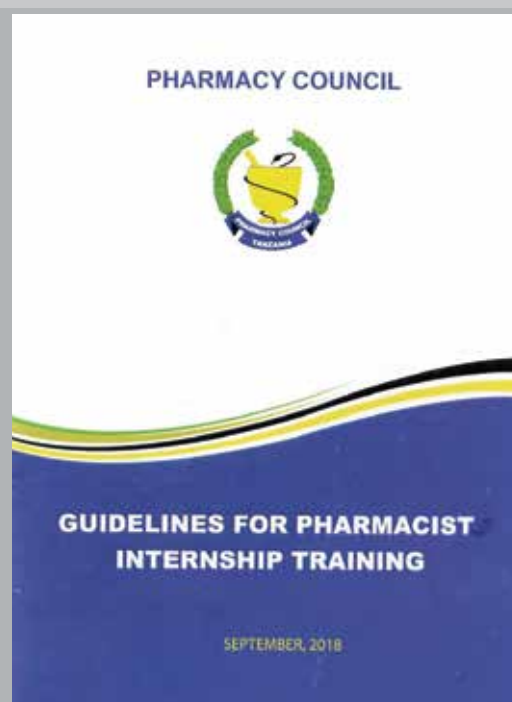
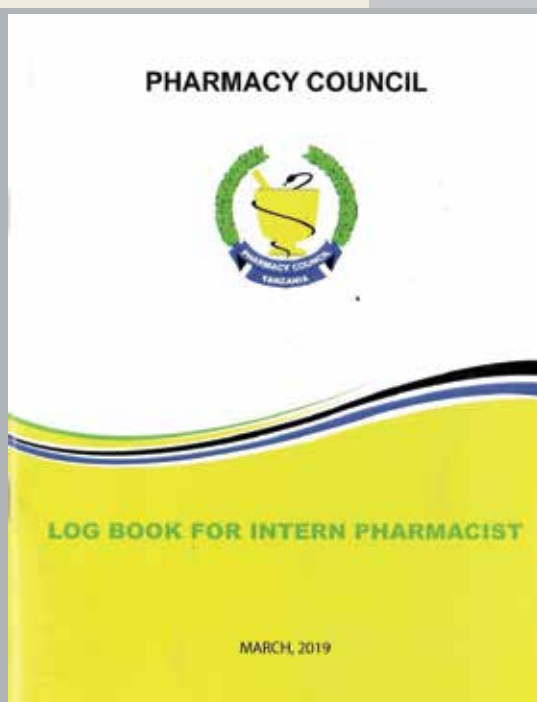
Internship Supervisors Trained

will serve as career development and growth to pharmacists and other professionals in the country. It will help the Council in monitoring how each regulated personnel is engaged in knowledge and skills development as required by law and regulations”

Under this e-learning platform pharmacists can go online and choose areas of interest to study and increase knowledge.

“We will be uploading the platform with up-to-date learning materials for every level of pharmaceutical personnel to keep them up-to-date since

medicines are changing,” Registrar explained.

The platform will consist of courses for pharmacists, pharmaceutical technicians and pharmaceutical assistants. The e-Learning system will be used as a tool to test the competence of professionals when applying for annual licenses since such professionals are required to learn at least three new pharmaceutical areas every year to keep them well-informed.

Millions of pharmacists worldwide celebrated World Pharmacists Day on 25th September 2019, whose theme was “safe and effective medicines for all.” It aimed at promoting pharmacists’ role in safeguarding patient safety through improving medication use and reducing medication errors.

As part of the World Pharmacists’ Day, 25th September, 2019, The Chairman of the Pharmacy Council, Pharmacist Legu Mhangwa launched the Council’s new and innovative e- Learning CPD platform amid fanfare at the Councils Sub Offices in Dar-es - Salaam.

The online platform will provide pharmacists, pharmaceutical technicians and assistants access to continuous professional development course materials. The platform will provide online capacity building courses aimed at sharpening professional skills for better performance and attaining proper qualifications required by laws and regulations.

In his launching speech, the Pharmacy Council Chairman, Legu Mhangwa said as Tanzanian pharmacists marked World

Pharmacists Day they should bear in mind that regular self-study on various topics of pharmacy and medicine in general is crucial. “We mark this day to remind ourselves our responsibilities, bring inspiration to young pharmacists and show the world our commitment to developing the International Pharmaceutical Federation (FIP),” Mr. Mhangwa noted.

“Continuous learning and studying is a weapon for continuous competence development and subsequently ensuring appropriate medicines selection, dispensing, counseling and rational use monitoring”, He added.

Tanzania Intern Pharmacist, Erick Venant (25), has been awarded, 'The Diana Award', a charity legacy in honour of Lady Diana, Princess of Wales. Erick has been awarded in recognition of his efforts to bring positive change in the health sector in the country. The award ceremony took place in the United Kingdom in July 2019.

As a pharmacy student, Erick was aware of antimicrobial agents and their impact on health worldwide, as well as the danger posed by the growing resistance to the lifesaving drugs. While still an undergraduate student, Erick led a team that successfully brought attention to antimicrobial resistance to schools all over the country through a nationwide campaign. Through television and radio stations, Erick reached a huge population of people, with antimicrobial ambassadors

continuing to spread the message within their communities.

His work has encouraged more people in health, agriculture and the community to pay more attention to the problem of antimicrobial resistance and their part in causing or addressing it.

The Diana Award develops and inspires positive change in the lives of young people through three key programs which include mentoring programs for young people at risk, a youth-led anti-bullying ambassador's campaign and a prestigious award which publicly recognizes young people.

Erick Venant is among 20 young people chosen from a pool of exceptional individuals as one of this year's Legacy Award recipients. The Legacy Award has been launched to inspire and celebrate the achievements

of outstanding young leaders, visionaries and role models across the world who demonstrate their ability to inspire and mobilise new generations to serve their communities.

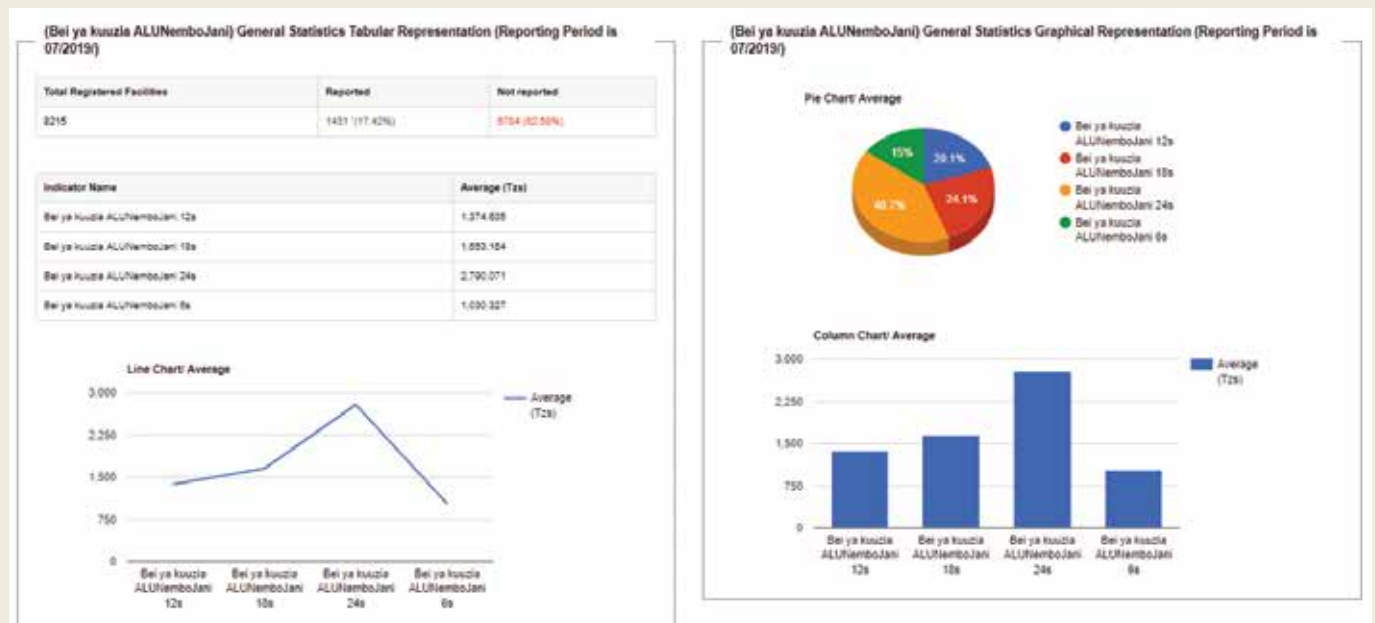

Council Conducts Training on Surveillance of Malaria and ACTs

More than 2627 participants, Owners and dispensers of Pharmacies and ADDO outlets from all districts and Municipalities of Singida, Dodoma, Manyara and Arusha Regions were trained on surveillance of malaria and ACTs. Training in the four regions took place between 30th July and 24th September, 2019.

The aim of the training is to impart knowledge to owners and dispensers on importance of recording patient's information, particularly malaria cases and their management for adults and under-fives attended at the drug outlets, and to submit the data to the Pharmacy Council on monthly basis as summarized reports through USSD enhanced mobile messages.

The training in the above four regions comes as continuation of similar training conducted in eight other regions namely Ruvuma, Njombe, Morogoro, Pwani, Lindi, Mtwara, Tabora and Kigoma. The training is conducted by the Pharmacy Council under sponsorship of the Global Fund.

The Council maintains a database which serves as a reservoir of all data received on monthly basis and is capable of sharing it with the National Malaria Control Program (NMCP).

Malaria is one of the top febrile illnesses and the leading cause of deaths in Tanzania. It is in that perspective that the Government has engaged the Private sector; dubbed as PPP by subsidizing the price of the first line choice of treatment of Malaria (Artemether/Lumefantrine-ALu). On monitoring and evaluating that approach, it was found important therefore the availability and price of the subsidized Alu should be surveyed. The plan is to complete the surveillance for all regions in Tanzania Mainland and weigh on the effectiveness of the approach.

It is in the expectation of the Council that the trained participants will send data in regular pattern that will aid the subsequent analysis.

Zambia Medicines Authority

Delegation on Study Visit

Five (5) delegates from Zambia Medicines Regulatory Authority (ZAMRA) and Pharmaceutical Society of Zambia paid a study visit to the Pharmacy Council Sub offices in Dar es Salaam between 11th and 17th August, 2019.

The objectives of the visit were, to familiarize with the Regulations of pharmacy practice, premises and personnel; to learn the implementation experience of the ADDO program; to undertake a field visit so as to familiarize with the operation of ADDOs and pharmacies and to attend an ongoing ADDO Training in Babati Town, Manyara region so as to interact with trainees and TOTs.

The Delegation was accompanied by their hosts in Tanzania – MSH Consultants headed by Dr. Suleiman S. Kimatta and Pharmacist Jafary Liana

On arrival at the Pharmacy Council offices, the delegation was given a brief overview of the Pharmacy Council by the Registrar, Ms. Elizabeth Shekalaghe. The delegation was then taken through all Pharmacy Council Departments and Units by the Council's Public Relations Officer Ms. Annette Ezekiel. The delegation showed particular interest on the ADDO unit and spent more time asking questions so as to have a thorough understanding of the functioning of the unit.

The next day, the delegation and their hosts together with the Deputy Registrar of Pharmacy Council Pharmacist Zainabu Nyamungumi and the Coordinator of ADDO Unit Pharmacist Wilbard Semvua travelled to Babati Town Council in Manyara Region to visit and witness the operation of ADDOs and ADDO Dispensers Training.

The delegation was welcomed by dispensers of ADDOs in Babati Town and conducted interactive interviews with them. Four (4) ADDOs and one (1) pharmacy were visited. "We are amazed by the trademark design of all visited ADDOs, uniquely branded and to a large extent similarities in internal arrangement of the storage and display area" One of the delegates remarked.

"Achieving this level of compliance to a set standard is a great success for any regulator, you don't achieve this easily. One should be honest and say this is a result of great efforts and commitment" Said by one of the delegates.

The delegation then attended an ADDO Training session which was under supervision of SIBS College based in Moshi. In this training, the delegation had long interactive discussion with the trainees. The

delegation then held separate discussion with the ADDO trainer of trainees, Pharmacist Herieli Maanga, who elaborated on his experiences and personal views on the ADDO program.

On return from Manyara the delegation paid an exit visit to the Registrar of the Pharmacy Council, thanking her for courtesy and hospitality extended to them. They expressed their gratitude and that they had gained a lot of knowledge from the visit and promised to draw a roadmap of implementing what they had learnt. They asked the Registrar not to be tired of their visits as they are sure to return to learn even more.

The Registrar thanked the visitors and welcomed them for further communications and expressed her joy for Tanzania being a role model country for devising this breakthrough mechanism for improving the access and availability of medicines, a persistent problem hampering most countries particularly the Sub Saharan Africa.

Madagascar Delegation on a Learning Visit

On 27th August, 2019 the delegation visited Mkuranga District Council so as to learn the way the District implements the ADDO Program. Four (4) ADDOs were visited and interactive interviews were conducted with the dispensers and owners of the ADDOs.

At Mkuranga, the delegation visited Ward Executive Officer. And learnt that the office of WEO is a significant step to be complied with by any person intending to establish an ADDO. The to and fro flow of process between street, village(VEO), Ward(WEO), District(DED), Region and to national level gave the delegation a great moment to learn the depth of coordination in Tanzania administrative systems.

Eight delegates from Madagascar Health sector were in the country from 25th to 31st August 2019 on a learning and familiarization visit on medicines and pharmacy practice regulation in Tanzania as well as learn about the ADDO program implementation experiences.

The delegation comprised representatives from the Ministry of Health of Madagascar, the equivalence of pharmacy Council, the Pharmaceutical society of Madagascar, the Medicine authority and a well-known "Impact Project" currently being implemented in Madagascar.

To achieve the objectives the study visit, the delegation was guided to visit the TMDA and its ISO certified laboratory, The Pharmacy Council, The City College of Health and Allied Sciences, Mkuranga District Council and The SHOPS PLUS Tanzania.

On 26th August, 2019 the visitors visited the TMDA where they met the officials and were briefed on the functions and scope of the TMDA. Thereafter they visited the ISO certified laboratory of the Authority.

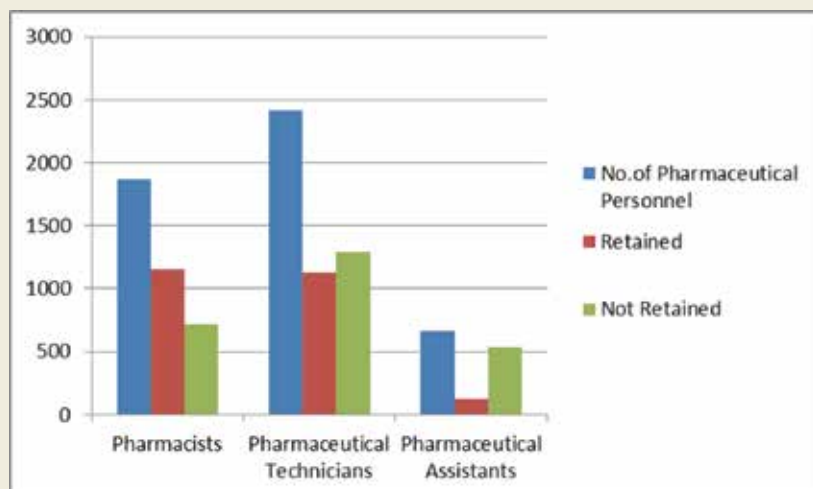
Together with the Pharmacy Council communication officer, the acting ADDO Program Coordinator and Apotheker the team headed to the City College of Health and allied sciences which is one of several institutions accredited by PC to conduct ADDO Trainings. The team had enough time to witness the learning environment as well as how the institution controls the training process from interview to the date of closing the training.

On 28th August, 2019 the delegation visited SHOPS PLUS, one of the not for profit NGO's which implements various health intervention projects through ADDO Program. In their presentation SHOPS PLUS revealed how beneficial the ADDO Program has been as a platform for such interventions. The representative of Impact Project of Madagascar had a good time to exchange experience with the SHOPS PLUS officials.

On 30th August the Madagascar delegation presented an exit briefing to the Pharmacy Council and their hosts MSH on the lessons they learnt in Tanzania in relation to the objectives of their visit. They thanks the MSH for sponsoring their visit and the Pharmacy Council for the knowledge and experiences shared.

Keep your Registration Status Alive – or Face the Wrath of the Law

A Glance of 2019 Retention Status of Pharmacy Professionals



Picture Caption1: Only 62% Pharmacists out of 1867, 47% Technicians out of 2421 and 19% Assistants out of 664 have retained their names in the Register, Roll and List respectively.

Pharmacists whose registration status is not active, meaning that they have not paid their annual fees, are at risk from being removed from the register. These individuals may lose the right to practice as pharmacists and can also be prosecuted in a court of law. The same applies to other pharmaceutical personnel cadres, pharmaceutical technicians and pharmaceutical assistants.

The Head of Registration has pointed out that, until the end of September 2019 less than 70% of pharmaceutical personnel have renewed their registration.

All pharmaceutical personnel are reminded to adhere to Section 22, 26 and 30 of the Pharmacy Act and retain their names immediately. Be reminded that practicing without a valid license is contrary to the law.

More New Pharmacies and Pharmacy Professionals Registered

A total of 74 pharmacies have been registered between July and September 2019. Registration has been completed after the applicants met all the requirements, including recruitment of registered pharmacists, refurbishment of premises and possession of reference materials.

Speaking to Pharmacy News, the Head of Registration and Qualification Recognition Department, Ms. Suma Jairo said that, 35 of the pharmacies are located in Dar es Salaam, three (3) in Coast Region, two (2) in Singida, two (2) Shinyanga, four (4) Mara, two (2) Geita, two (2) Songwe, three (3) Tanga, Three (3) Morogoro, four (4) in Mwanza, four (4) Mtwara, one (1) Arusha, three (3) Mbeya, three (3) Dodoma, two (2) Katavi and one (1) in Kigoma. She further said, "Twenty of the pharmacies are owned by pharmacists".

In another event the Council has also registered five new pharmacists, enrolled 78 pharmaceutical technicians and enlisted six pharmaceutical assistants.

According to Pharmacy Act 2011, new pharmacies will become operational after fulfilling the entire regulatory requirements. The same applies to pharmacists, pharmaceutical technicians and assistants.

The Office of the Registrar receives substantial number of applications to pursue and operate pharmacy business. To date, the Council has registered 1676 pharmacies and a total of 226 pharmacy businesses have been closed down at different point of time due to various factors.

Pharmacists Donate Medicines In Corporate Social Responsibility Gesture

Pharmacists Owners of Pharmacies in Tanzania (POPTA) on Monday 12th August 2019 donated medicines and other medical supplies to Muhimbili National Hospital (MNH) for casualties of the fuel tanker explosion that occurred on 10th August 2019 in Morogoro region.

Speaking during the handing over of medicines and medical supplies held at MNH, POPTA Representative, Pharmacist Henry B. Tandau said; The Association was saddened by reports of the accident and felt that the injured persons needed to be assisted especially with medical supplies.

“The medicines and medical supplies we have brought are the most urgently needed, including Burnox Cream, Infusions, Gauze rolls, examination gloves and cotton wool which are normally the pharmaceuticals used to treat burn injuries” said pharmacist Tandau.

He added that the pharmaceuticals worth more than Five Million Tanzania Shillings (TZS. 5,000,000/=) had been donated in an immediate response, but if there are more requirements POPTA was ready to continue supporting efforts of His Excellence President Dr. John Joseph Pombe Magufuli who had visited the casualties at the hospital.

Receiving the medicines and medical supplies on behalf of MNH management, the Hospital Chief Pharmacist Dr. Deus Buma along with the Head of Sterilization Department Ms. Batusaje John Mwaibanje acknowledged POPTA for supporting MNH in caring for the patients as the pharmaceuticals received were exactly what was required in fire casualties treatment.
