### PROFESSIONAL EXAMINATIONS CONDUCTED IN APRIL, 2019 Emily Murakiboliva



The Pharmacy Council conducted professional examinations for fifteen (15) candidates from 17th – 18th April, 2019 in Dar es Salaam for pharmaceutical technicians and pharmaceutical assistants and ten (10) candidates passed the examination. Passing of professional examinations is one of the requirements for a person to be registered, enrolled or enlisted as a pharmaceutical personnel according to Pharmacy Act, Cap 311.

The Registrar urges all employers to employ only recognized pharmaceutical personnel and not otherwise. Also she emphasized that the Council will be there to continue ensuring that all pharmaceutical personnel comply with the codes of ethics and professional conduct in their working places.

# Pharmacy Council focuses on upgrading its o

The Pharmacy Council is now focusing on upgrading its operational systems in order to curb the challenges beclouding its operations. This was revealed by the Council's reappointed Registrar, Ms. Elizabeth Shekalaghe (ES) during a one to one exclusive interview with PC Newsletter Senior Editor, Henry Tandau (HBT). Following is an excerpt of the interview.

HBT: First of all I would like to take this opportunity to congratulate you on your re-appointment as Registrar of the Pharmacy Council for another five year term, as that is an indication of the good and exemplary job you have done in steering the Council during your first term.

Madam Registrar, you took office for the first time in April 2014, when the mandate of the Pharmacy Council had been expanded significantly, following the enactment of the Pharmacy Act, 2011, which obligated the Council to oversee Pharmacy practice within the entire public including some aspects that were previously under TFDA, can you briefly outline the achievements that you have had so far?

**ES:** Well first of all let me say thank you for the compliments, though it is a fact that whatever I have achieved so far is a result of teamwork. The Pharmacy Council is blessed to have staff who work together diligently and dedicated to our roles and responsibilities. Teamwork is very important, so thank you on behalf of all Council Board members and the entire staff.

Now back to your question, during the first tenure of my position as Registrar of the Council, we have achieved a lot, much as a lot is still to be done, as you may well know that quality has no end.

The priority during the first term was to set-up internal working systems so as to improve our way of working thus bringing in efficiency and effectiveness, something I would say we have achieved to a large extent, such as the institutional capacity to deliver efficient and quality services has been strengthened by instituting ICT policies and tools that transforms from the manual operations (traditional) to digital operations. This is in line with e-Government policy. Moreover, the Pharmacy Council is now known and understood more than before through involvement of various activities with our stakeholders.



Furthermore we now have guidelines and most of the key regulations in place, our database of key stakeholders is almost complete, our communication has improved a lot. However, we are still working on improving that.

#### **HBT:** It is about two months since you were reappointed as the Registrar of the Pharmacy Council. How do you feel about this very important responsibility?

**ES:** The two months have been really exciting and of course have given me the time to reflect on the past and identify gaps and challenges which were not addressed in the previous term as well as to visualise on the best ways to deal with them. I am definitely excited about the future, to make the Pharmacy Profession, the most respected profession in the country, and a profession every parent would want their children to pursue, a profession that will standout above all other professions in the country because that is where the phamacy profession belongs. To do that the Council needs all the

themselves and all the relevant stakeholders. I believe it is possible.

HBT: What are some of the major challenges experienced so far in your tenure in the office, and how do you intend to address them?

ES: Malpractice is still prevalent in several parts of the country, because of the perception that medicines can be sold like any other commodity. The self-medication is also alarming and in some areas you can access prescription medicines without prescription which leads to drug resistance. We still have some unlicensed drug

dealers reluctant to adhere to the requirements of the law. Inadequate manpower is again another challenge considering the size of our country, equipment and tools are also a challenge, especially transport to rural areas, however, we are doing our best to make efficient use of what we have and so far so good.

HBT: Your re-appointment has been very well received by many stakeholders in the country's pharmaceutical sector and are now looking upon you to continue provide leadership to the profession. How do you plan to go about this?

ES: I look forward to working closely with all the stakeholders, seek their support and their participation. I am open and ready to receive their views and opinions that will bring positive change and impact to this profession. I will continue to adhere to the law and regulations. I shall not tolerate any individual who will go against them.

support of the pharmacists HBT: How do you see the Pharmacy Council changing in the next five years of your new tenure, and how do you see yourself creating that change?

> ES: I plan to automate our internal and business flow processes including online applications and issuance of various licenses and permit. The system will easy the huddles faced by our stakeholders during accessing our services and it will provide us with accurate data of all the personnel and premises registered under the Act. I believe, proper use of this system will streamline business processes and improve efficiency and effectiveness of service delivery. I have a plan to put in place a system for monitoring and evaluation of PC functions that will monitor all of our functions. This will enable us to improve our performance and achieve organizational targets and goals. Quality Assurance system by developing and improving different mechanism of operations which will assure quality of our functions to meet our customers' expectations.

> We look forward to engaging all relevant authorities including the President's Office - Regional Administration and Local Government (PO- RALG) in order to familiarize them with our systems due to the delegated functions that have been vested to them to oversee some of Pharmacy Council operations within their respective areas.

> HBT: What message would you like to pass on to pharmacists and all stakeholders regarding your roles in the next phase?

> ES: I urge that each one of us should be accountable and responsible to whichever tasks given by our supervisors and continue to abide with professional ethics. We must all learn not to fear change, but to embrace it enthusiastically and, perhaps even more important, encourage and drive it.

> HBT: Thank you for your time, and I wish you the best and success in your position.

This finalization follows previously conducted two (2) review meetings in 2018 which involved different stakeholders from Ministry of Health, Community Development, Gender, Elderly and Children (MoHCDGEC), National Board of Accountants and Auditors (NBAA), Engineers and Registration Board (ERB)

lawyers, National Council for Education (NACTE), Technical Tanzania Commission for Universities (TCU), Muhimbili National Hospital (MNH), Jakaya Kikwete Cardiac Institute (JKCI), Attorney General lawyers, Kampala International University in Tanzania (KIU) and Muhimbili University of Health and Allied Sciences (MUHAS).

### PRE-REGISTRATION AND PROFESSIONAL EXAMINATIONS FOR PHARMACEUTICAL PERSONNEL By Emily Mwakibolwa

Two hundred and ninety five graduates of different courses in pharmacy have sat for pre-registration and professional examinations on 19th – 20th June 2019 as one of the requirement to be registered to practice as a pharmaceutical personnel. The examinations were conducted in five (5) centers. Dar es Salaam, Mwanza, Mbeya, Dodoma and Moshi.

These are the first examinations to be conducted based on newly approved guidelines which came into effect in January 2019 after being approved by the Council. In these new guidelines a candidate is required to pass three examinations which will measure their competences in different areas of practice before being registered to practice as a pharmaceutical personnel.

The Council calls for every graduate in pharmacy course not to practice as a pharmaceutical personnel before being registered.

The provisionally approved training institutions include K'S Royal College of Health Sciences located in Mbeya Region which is approved to offer up to diploma in pharmaceutical sciences (NTA L4-6) and Green Bird College which is located in Mwanga and was approved to offer up to certificate in pharmaceutical sciences (NTA L4-5).
